Also just don't come out so hard right out of the gate, definitely explain the class and the level it will be at, but also make sure there is room for mistakes the first couple of weeks.

A few weeks fixed where things can slow down. The course is at one constant pace, very fast.

People should not be kicked out for not fully understanding the material. If anything, they should at least get to stay and listen to the conversation. I feel like that would be more helpful, especially if they already didn't understand the reading on their own.



The class was led by discussion and it really helped me to engage in the material being taught


